Purpose:

To detail how a student may complete first year coursework in the event of not successfully completing it during their first year of enrollment.

Policy for Our Human Heritage Courses (FYHH 1010 and FYHH 1020):

Students who do not successfully complete (either because of failure or withdrawal) FYHH 1010 during the Fall semester must continue into FYHH 1020 during the Spring semester. However, students will not be allowed to repeat FYHH 1010 during the next Fall semester; instead, they must take a course from the approved substitution list below. This substitution course must be taken during the Fall or Spring of their second year.

Students who do not successfully complete (either because of failure or withdrawal) FYHH 1020 during the Spring semester will not be allowed to repeat FYHH 1020. Instead, they must take a course from the approved substitution list below. This substitution course must be taken during the Fall or Spring of their second year.

Students who do not successfully complete (either because of failure or withdrawal) both semesters of FYHH 1010 and FYHH 1020 will be required to take two courses from the substitution list below. These courses must be completed by the end of their second year.

Substitution courses used to fulfill the Our Human Heritage requirement may not double-count to fulfill another knowledge domain within the Compass Curriculum; for more information, see college catalog for policy on double counting courses.

Approved Substitution List:

This list contains historically oriented, humanities courses in art, music, theatre, history, philosophy, religious studies, modern languages, English, classical studies, and archaeology. The following courses are currently on this list. This list is subject to change. In order for a course to be added to this list, Department Chairs should contact the Coordinator of *Our Human Heritage*.

Policy for Ventures (FYCS 1010) and Connections (FYCS 1020) Courses:

If a student does not successfully complete (either because of failure or withdrawal) FYCS 1010 Ventures during the Fall semester, they must take FYCS 1020 Connections during the Spring semester. To complete the Ventures course, the student has two options:

1. Repeat FYCS 1010 Ventures during the next Fall semester.
2. In lieu of repeating FYCS 1010 Ventures, the student may take TRCS 1050 Discovery. Thus, the student would be enrolled in FYCS 1020 Connections during the Spring semester of their freshman year, and TRCS 1050 during the Spring of their freshman year or Fall of their sophomore year.

*Both options require that the student makeup the course in which they failed or withdrew from during the next 2 regular-academic-year semesters.

If a student does not successfully complete (either because of failure or withdrawal) FYCS 1020 Connections during the Spring semester, the student may take TRCS 1050 Discovery during the next Fall semester or they may wait to repeat FYCS 1020 Connections during the Spring semester of their sophomore year. It is required that the student makeup the course in which they failed or withdrew from during the next 2 regular-academic-year semesters.

If a student fails to complete both FYCS 1010 Ventures and FYCS 1020 Connections (either because of failure or withdraw), the student may take TRCS 1050 Discovery in lieu of one of the classes but must repeat the other. The student may choose which class they would like to repeat. It is required that the student makeup the courses in which they failed or withdrew from during the next 2 regular-academic-year semesters.
